As indicated by my initials, and in consideration for being permitted to participate in the Rotary Club of Washington County Demolition Derby and related activities (the "Derby"), I agree as follows:

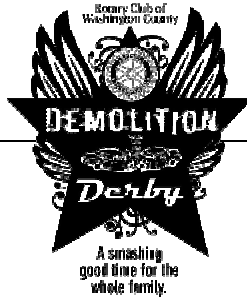
Indemnification and Waiver of Liability: On behalf of myself, my heirs, personal representatives, and assigns, I release and indemnify Rotary Club of Washington County, and its officers, directors, members, contractors, volunteers, agents and representatives (the "Rotary Parties") for any and all claims, demands, losses, judgments and costs, including attorneys' fees, that may be incurred in connection with any injury to property or persons, including death, arising out of my participation in the Derby or my presence on the premises of the Derby location. Risks Assumed: I understand that the following are some of the risks associated with the Derby and I freely and voluntarily assume these risks. I do this knowingly, waiving any and all rights of my heirs, personal representatives or assigns, to seek any reimbursement from the Rotary Parties, including but not limited to damages for medical expenses, lost income, loss of earning capacity, hardship, pain and suffering, and mental anguish.

1. While driving or riding in a vehicle, it may sustain damage or loss of power, which could cause the vehicle to crash, resulting in property damage, bodily injury and/or death. (_____) Initials
2. Participants and observers may be struck by moving vehicles or parts or debris from vehicles, even as they are entering or leaving the property, and this may result in property damage, bodily injury, and/or death. (_____) Initials.
3. Fuel tanks, engines, or other parts of vehicle may catch fire or explode, resulting in property damage, bodily injury and/or death. (_____) Initials
4. Participants, spectators, volunteers, officials or others may commit acts that are willful, negligent, careless or reckless, or acts of error or omission, which may result in property damage, bodily injury and/or death. (_____) Initials
5. Risks that result in injury to person or property may be compounded or increased by the negligence of rescue personnel or of the responsive action of Rotary Parties. (_____) Initials
6. I understand that all hazards associated with the multiple activities taking place in connection with the Derby cannot be fully explained or described in any document and that the risks mentioned above represents only some but not all of the hazards I may encounter as a result of participating in the Derby. It is my responsibility to obtain the knowledge to assess all the risks involved. I am not

relying on any of the Rotary Parties in making a decision to participate in the Derby. **I understand that I am at risk and I agree to participate anyway.** (_____) Initials

7. **Responsibility for My Safety:** I understand and agree that I am responsible for my own safety while I am participating in the Derby or present near any Derby activity. I will inspect the safety of the areas that I enter in connection with the Derby and, if at any time I am aware or feel that anything is unsafe, I will immediately advise a Derby official and I will leave the area immediately and refuse to participate in those activities. 8. **Release/Acknowledgement of Risks for Minors:** On behalf any person under 18 years of age for whom I am legally responsible and who is present with me at the Derby (hereinafter "Minor(s)"), I hereby acknowledge, agree, promise, and covenant with, and release and discharge the Rotary Parties, their/our heirs, assigns, personal representatives, and estates as follows: for any and all claims, demands, losses, judgments and costs, including attorneys' fees, that may be incurred in connection with any injury to property or persons, including death, arising out of Minor(s)' participation in the Derby or Minor(s)' presence on the premises of the Derby location. (_____) Initials
9. **Insurance Waiver:** I understand that my participation in the Derby is not covered by any personal accident or general liability insurance policy that may be issued to the property owners or Rotary Parties or any other persons associated with the Derby. I am responsible for providing my own insurance. (_____) Initials
10. **Medical Statement:** I certify that I do not suffer from any physical infirmity or chronic illness which would adversely affect my ability to participate in the Derby. I further certify that I have not taken any prescription or over-the-counter drugs or consumed alcoholic beverages to an extent that would adversely affect my ability to safely participate in the Derby or my ability to read and understand the full implications of this Release and Indemnification Agreement. 11. **Media Release:** I grant permission to the Rotary Parties and their assigns to use my voice, likeness, photograph, or video image in any and all promotional material and media in connection with advertising and promotion of the Derby. (_____) Initials
12. **Damage to Property:** If I am responsible for damage of any property in connection with the Derby, other than destruction of another participant's vehicle in the course of running the Derby, I agree to pay the full and complete costs of replacement and repairs to restore it to its condition at the time of the Derby. (_____) Initials
13. **Final Statement of Unconditional Release:** I have carefully read and signed this document with the understanding that I am releasing all of the Rotary Parties from any and all liability. I understand that I am responsible for my actions and deeds, including complying with all applicable laws while I am involved in any activity in connection with the Derby. I am responsible for following the rules set forth by the Rotary Parties in connection with the Derby. I am executing this document of my own free will, voluntarily, without peer pressure, coercion or mental reservation. I am of sound mind and completely sober, and I understand that by executing this document I have given up substantial rights without any inducement, assurance, or guarantee. (_____) Initials
